Secretary Report

Gold Star Committee Report – Brian MacMurdo - Nominations for 2023 Gold Star Awards will open December 1st. Scott Brown will be transitioning to the Chairman role of the Gold Star Awards Committee.

Ohio 9-1-1 Program Office Update – Patrick Brandt

Next Gen project is moving along. By early December the next 4 pilot counties should be announced. Solocomm is the hosted state solution. The Solocomm Vendor will not come out to PSAPs to demo or show their product until election forms are received that

show interest into the state hosted solution. County plans due to Ohio Program Office April 3, 2024. The office is working on templates for county 911 plans. Once the templates are complete and reviewed they will be made available. The November payments were sent out in full which included the 25% that went to the NexGen fund which was transferred back to the WGAF fund and paid out to counties. The Program Office cannot provide estimates on future funding to counties based on new funding model. The NG911 Road show video will be recorded next week and then will be available on the website. Sharon McMurray advised that as of the end of November, all counties will have had to submit their reports by the end of November. Sharon is still waiting on 7 counties to provide with additional information. So far, all counties are in compliance. There is a new report required under 128.06e. This new report will be due March 1st each year starting in 2024. All revenues and expenditures must be reported. This report includes ALL revenues not just WGAF funding and ALL expenditures. Report must be turned into Program Office and out to the Political subdivisions. State Auditor's office may contact PSAPs to review funding to fulfill their reporting responsibilities in 2025.
