Gold Star Committee Report – Brian MacMurdo

Gold Star nominations for 2022 were due by January 31st. The nomination period has been extended to March 31st. The nomination link is available on both the Ohio APCO and Ohio NENA websites and Facebook.

Ohio 9-1-1 Program Office Update – Rob Jackson

The office is working on the required 2 hours of continuing education for 2023. The training is being coordinated with CISA that will provide a 2-hour cyber security live webinar that will be recorded and then available for everyone. The updated PSAP rules do require an additional six hours of continuing education which can be determined by each agency. Sharon requests that when providing documentation for the additional training, please provide the name or type of training and numbers of CEU hours. Sharon McMurray advised that the 2023 compliance cycle has started. The FCC and the

National 911 Office surveys will be coming out in the spring. The deadlines are set by those agencies. Please get those surveys completed and returned by the deadlines.

NG911 funding information. **Senate Bill 50** – legislation replacing HB 445 was introduced into the Senate. SB50 will be read in the senate and will have to go back through the committee process. Legislation was introduced with the original \$.25 per device fee rather than the \$.70 device fee. Legislators have advised that was by mistake according to APCO legislation liaisons. The hope is that the legislation will pass yet this year; however, the legislation takes 90 days to become law and another 6 months for taxation to come in and work could start on the ESINet sometime in 2024. https://www.legislature.ohio.gov/legislation/135/sb50

Governor DeWine announced his proposed 2023-2024 budget while visiting Trumbull County. The proposed budget includes funding for the statewide Next Generation 911 System totaling \$45.9 million for NG911infrastructure. If the budget is approved with the NG911 funding included, funding would become available June 1, 2023. This would allow the State to begin building the Ohio ESINet much sooner. The Governor's funding is separate from the funding in SB50 and will provide a 2-year pot of money to begin the build out of nonrecurring cost to NG911. The ESINet Steering committee will determine how the funds will be accessed. There is possibility of funding the start of the state NG911 building as well as local grant opportunities through the State Fire Marshall's Office. Next ESINet Steering Committee meeting is 2/27/23.
